## Introduction and overall objective

The TESS Environmental Information workshop will be delivered in London September 14-16 2009 in combination with the 3<sup>rd</sup> PMC meeting for the project.

The results of WP2 and WP3 will be presented by the Work Package leaders. All TESS partners with a Case Study area will have contributed to two Information Surveys designed to capture the environmental decision-making process and information flows from national to local levels. The WP2 survey will have focused on National systems and the WP3 survey on information flows for environmental decision making by local administrations, communities and individual citizen stakeholders.

The main objective will be to collate the WP2 & 3 surveys to characterise the range of systems, processes and information flows likely to be encountered across the diverse governance, cultural and habitat systems in the study. The output will be summarised into conceptual models to demonstrate similarities and differences between the TESS case study areas.

The secondary objective will be to brief the country co-ordinators for the WP5 surveys and to address any problems they may foresee.

A number of distinguished experts will be invited to give short presentations and contribute to their insights to the workshop in structured discussions. Their contributions will form part of the final synthesis report from WP2/WP3.

### Adjustments to Deliverables D2.1 & D3.1

After consultations at the delayed KO meeting in December it was noted that these deliverables referred to a single event, best described as "Environmental Information Workshop", which would be fixed by month 4 and held by month 12. Planning of the agenda, speakers etc were finalised at the 2<sup>nd</sup> PMC in Slovenia after consultation with all the partners and submitted by 31 March 2009 as a revised deliverable.

### Links to future work packages

**WP4** – The results of WP2 and 3 are key to ensuring that the predictive models collated and analysed within WP4 are 'fit for purpose'. They will indicate the 'demand' for environmental information to compare with the potential 'supply' assessed in WP4.

**WP5** -The results presented at the workshop are essential for informing the questionnaire survey for the 27 EU states to be carried out in WP5. They will indicate the types of information flow and governance of environmental decision making across the EU, which will then be quantified for each state through the survey. This process will have been ongoing during the completion of the work for WP2 and 3 in order to produce a training package for the delivered country coordinators to be on day 2 of the workshop.

**WP6** - The review of SEA and EIA procedures will inform the review of effectiveness of these instruments in to be conducted in WP6. The WP6 review will consider a range of SEA and EIA protocols to determine the effects of differences of implementation on biodiversity and ecosystem service. The conceptual models of information needs and flows are also crucial for designing the transactional decision making system.

# Budget

The total budget is €10250 = £9494 (Based on current exchange rates £1 = €1.07).

Booking the conference rooms including lunch, refreshments and all equipment for 3 days 14-16 September has been agreed at total cost of £7875. It is calculated per delegate using a day rate of £52.50 each, assuming 30 PMC participants on day 1 and 60 workshop participants on days 2 & 3.
